### 2022 Farmers Market Guidelines

Thank you for supporting the Heathsville Market. The Market is run by Tavern volunteers and you help keep this historic site alive with your participation.

**Schedule:** Third Saturday of the month from **April through October**.

**Hours:** 9 am to 1 pm. Vendors may arrive and begin setting up at 7:00 a.m. The Market operates rain or shine. **ALL VEHICLES MUST BE OFF THE FIELD BY 8:30 AM.**

**Spaces:** The spaces are approximately 12' x 12'. ALL of your display equipment and items need to fit within your space. If you bring a tent – Please make sure you can set up your own equipment. You should have weights or pegs to tie your tent down. Outside field spaces are given priority to farmers and vendors with heavy items or refrigerated produce/meat.

**5 spaces are allotted for Non-Profit 501 (c) (3) organizations.**

The Market reserves the right to limit the “types” of For Profit and Non-Profit Vendors. These rules benefit the community and vendors alike, helping to make the Market pleasing and informative for all.

### 2022 Fee Schedule

Check Availability of Pavilion – many months are sold out!

Vendor Fee (By the month or by the season):

**Pavilion: \$25** per space per month or \$150 for one space if paying in advance for the whole season (Gives you a \$25 discount)

**Field Space: \$20** per month per space or \$120 for one space if paying in advance for the whole season (Gives you a \$20 discount)

Non-Profit Organizations 501(c) (3):

**Field: \$10** per space per month (Gives you a \$10 discount)

- **No Show Policy:** Vendor no-shows hurt the Farmers Market reputation and other vendors. If you are a no-show, you may lose your space and be put on a waiting list for space availability.
- **Cancellations:** Problems come up; it is your responsibility to let the Market Manager know if you cannot attend. If you cancel 2 markets, you may be put on the waiting list for space availability.

- All vendors must comply with the State of Virginia Agriculture and County health codes.
- There is no loaning, sharing or subletting of space.
- MUST provide a current inspection report from the Virginia Department of Agriculture or Virginia Health Department, if applicable.
- Be responsible for the safety & purity of all products offered for sale.
- Cooperate with RHHT's manager in charge of the market; no space will be assigned without prior approval.
- **ONLY 1 VEHICLE MAY BE PARKED AT THE ALLOTTED SPACE. ALL OTHER VEHICLES NEED TO BE MOVED TO THE PUBLIC PARKING AREAS.**

Vendors shall hold the Market Manager, Farmers Market Management and Rice's Hotel/Hughlett's Tavern Foundation harmless from any liability whatsoever that might result from their activities at the Farmers Market.
